No.SO (Boards)13-1/2020-SSC(A):- Pursuant to the provisions of section 4 of the Punjab Essential Services (Maintenance) Act, 1958 (XXXIV of 1958), I, **Sajid Zafar Dall**, Secretary to Government of the Punjab, Higher Education Department, being satisfied that the public interest so requires, do hereby order as follows:
